Sub: Grant of First Time Affiliation for the Academic Year 2024 – 25.

Sir,

As per the provision of section 65 (4) of Maharashtra University of Health Sciences Act 1998, I am directed to inform you that, on the basis of the Local Inquiry Committee report and Circulatory Permission from Academic Council vide Resolution No. 209/2024 the Hon'ble Vice Chancellor is pleased to Grant First Time Affiliation to, "Synergy College of Nursing, Maji Sainik Vasahat, Miraj, Dist. Sanglii." B.Sc Nursing Course for the Academic Year 2024-2025. However, this affiliation is subject to the following conditions:-

- 1) The intake capacity shall be 50 Students for B.Sc. Nursing Course.
- 2) Rules and Regulations made by Indian Nursing Council, New Delhi, Govt. of Maharashtra and the University, as amended from time to time, will be binding on the College.
- 3) The College should obtain approval of teachers from the Maharashtra University of Health Sciences, Nashik.
- 4) The College should obtain the permission for admitting the students from the Admission Regulating Authority, Mumbai.
- 5) College should obtain approval of fee schedule for the admission of the students from the Fee Regulating Authority, Mumbai.

- 6) This First Time Affiliation is Valid for Academic year 2024-25 only.
- 7) The next batch of students shall not be admitted unless continuation of affiliation from the University is obtained by the College.
- 8) It is mandatory for the College / Institute to register on AISHE portal and submit the required data on AISHE portal time to time.
- 9) Your College shall comply with 18' d" of INC Norms for not having own building.
- 18 d) Penalty for not having own building: Institutions which do not have their own building within two years of establishment has to pay the penalty for not having the own building. The penalty fees is Rs. 50,000 for ANM program, Rs 50,000 for GNM program and Rs. 1 Lakh for Collegiate program (i.e. B.Sc. (Nursing), P.B.B.Sc. (Nursing), M.Sc. (Nursing) and NPCC) for 6 consecutive years. Even after 6 years if the institution does not have own building then action shall be taken under Section 14 of the Act. However, a lease of 30 years is permissible with the Trustee of the institution. If compliances are not made said First Time Affiliation will stand cancelled.
